5. Fees remaining unpaid after week 3 of term will attract a late payment/administration charge of \$27.50 unless a payment arrangement has been discussed with the principal.

8. VSSS reserves the right to refuse admission to any students whose fees remain unpaid.
9. If you choose to pay by cheque, please note that if you have insufficient funds in your account, any cost incurred to us will be oncharged.
